Arrangements relating to Vendor's temporary suspension of the sales of first-hand residential properties due to the No.8 or higher Tropical Cyclone Warning Signal and / or the Black Rainstorm Warning Signal from 1 July 2025 until 31 December 2025 (both days inclusive)

Tropical Cyclone Warning Signal

When the No. 8 or higher Tropical Cyclone Warning Signal is hoisted by the Hong Kong Observatory at any time between 12:00 noon and 7:00 p.m. from 1 July 2025 until 31 December 2025 (both days inclusive), the Vendor will close the Designated Venue where the sale will take place (and if it is cancelled or replaced by a No.3 Tropical Cyclone Warning Signal or below less than four (4) hours before the end of the Time of the Sale). The closing date and time of the tender will be postponed to 7:00 p.m. on the following day, provided that the No.8 or higher Tropical Cyclone Warning Signal is

cancelled or replaced by a No.3 Tropical Cyclone Warning Signal or below between 12:00 noon and 7:00 p.m. on that following day.

Black Rainstorm Warning Signal

When the Black Rainstorm Warning Signal is issued by the Hong Kong Observatory at any time between 12:00 noon and 7:00 p.m. from 1 July 2025 until 31 December 2025 (both days inclusive), the Vendor will close the Designated Venue where the sale will take place (and if it is cancelled or replaced by a lower level alert less than four (4) hours before the end of the Time of the Sale). The closing date and time of the tender will be postponed to 7:00 p.m. on the following day, provided that the Black Rainstorm Warning Signal is cancelled or replaced by a lower level alert between 12:00 noon and 7:00 p.m. on that following day.

熱帶氣旋警告信號

2025 年 7 月 1 日起至 2025 年 12 月 31 日(包括首尾兩天)中午 12 時至下午 7 時期間，如香港天文台發出八號或以上熱帶氣旋警告信號（及如該次熱帶氣旋警告信號取消或改為三號或較低的警告信號時距出售時間終止不足四(4)小時的），賣方會關閉指定會場。倘若翌日中午 12 時至下午 7 時期間該次八號或以上熱帶氣旋警告信號已取消或改為三號或較低的警告信號，招標截止日期及時間將會順延到該翌日下午 7 時。

黑色暴雨警告信號

2025 年 7 月 1 日起至 2025 年 12 月 31 日(包括首尾兩天) 中午 12 時至下午 7 時期間，如香港天文台發出黑色暴雨警告信號（及如該次黑色暴雨警告信號取消或改為較低級別的暴雨警告信號時距出售時間終止不足四 (4)小時的），賣方會關閉指定會場。倘若翌日中午 12 時至下午 7 時期間該次黑色暴雨警告信號已取消或改為較低級別的暴雨警告信號，招標截止日期及時間將會順延到該翌日下午 7 時。
