## Batch A

1. First come first served. Any person interested in purchasing any of the specified residential properties (“**Prospective Purchaser**”) (if the Prospective Purchaser is a company, then any one of its directors) must:-
  - (a) personally (or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend the Sales Office; and
  - (b) bring along his/her H.K.I.D. Card(s)/Passport(s) and cashier order(s) and (if applicable) copy of Business Registration Certificate and documents filed with the relevant companies registry or such other documents showing the current list of director(s) and secretary to the satisfaction of the Vendor (whose decision shall be final) and a copy of H.K.I.D. Card(s)/Passport(s) of the director(s). The number of cashier order(s) shall be equal to the number of specified residential property(ies) to be purchased by the Prospective Purchaser. Each cashier order shall be in the sum of HK\$100,000 and made payable to “MAYER BROWN”.
2. For the purpose of determining the order of priority, the Vendor does not accept any person having queued up at the Sales Office before the commencement time of sale.
3. In case of any dispute, the Vendor reserves its absolute right to allocate the specified residential properties to any person interested in purchasing by any method (including balloting).
