Persons interested in purchasing any specified residential properties must attend the Sales Office in person or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor to select the residential properties that the person wishes to purchase. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
