1. The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to accept any offer at or before the closing time of the tender. The Vendor has absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.

If No. 8 or higher Tropical Cyclone Warning Signal or Black Rainstorm Warning Signal is hoisted by the Hong Kong Observatory at any time between 12:00 noon and 7:00 p.m. on the closing date of the tender (i.e. every Date of Tender), the Vendor will close the sales office where the sale will take place. The closing date and time of the tender will be postponed to 7:00 p.m. on the following day, provided that the No.8 or higher Tropical Cyclone Warning Signal is cancelled or replaced by a No.3 Tropical Cyclone Warning Signal or below; or Black Rainstorm Warning Signal is cancelled or replaced by a lower level alert between 12:00 noon and 7:00 p.m. on that following day.
在招標截止日期(即每個招標日期)當日中午 12 時至下午 7 時的任何時間內，如香港天

文台發出八號或以上熱帶氣旋警告信號或黑色暴雨警告信號，賣方會關閉售樓處。倘若翌日中午 12 時至下午 7 時期間該次八號或以上熱帶氣旋警告信號已取消或改為三號或較低的警告信號，招標截止日期及時間將會順延到該翌日下午 7 時。

3. Persons interested in submitting tenders of the specified residential properties are reminded to read the latest Register of Transactions of the specified residential properties so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender after the close of that previous tender exercise. Please note also that the Register of Transactions of the Development may not be updated immediately after the Vendor accepts a tender.
