The Vendor has the absolute right to accept any tender at or before the tender closing date and/or time. The Vendor has absolute right to change the tender closing date and/or time in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.
- (b) Persons interested in submitting tenders of the specified residential properties are reminded to ~~read~~ examine the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the acceptance period after the tender closing date of that previous tender exercise.
- (c) Please note that entry of any person into the Location of Tender Box will be subject to satisfactory check of **normal** body temperature on-site. Any person entering into the Location of Tender Box is required to wear a self-provided **satisfactory** surgical face mask at all times while at the Location of Tender Box.
