A. Where more than one residential property is covered in one preliminary agreement for sale and purchase, the purchaser of such residential properties shall comprise the same person or the same group of persons.

B. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

- B. The Vendor has the absolute right to sell or dispose of any or all of the specified residential properties (herein offered to be sold) to any person by any method from time to time by amending this Sales Arrangements or any other appropriate means. 賣方有絕對權利不時透過更改本銷售安排或其他合適的方式以任何方法向任何人士出售或處置任何或所有(在此銷售安排供出售的)指明住宅物業。
- C. The Vendor reserves the right at any time, (a) for the purpose of maintaining security and order at the Sales Office, safety of the visitors and/or smooth operation of the sales procedures and/or (b) due to disrupted access to the Sales Office and/or (c) where there is any event or circumstance affecting or which may affect the safety, order or public health in the Sales Office and/or (d) for the purpose of protecting the health of the visitors and other participants in the Sales Office, to amend this Sales Arrangements and/or suspend the sale of all the remaining unsold residential properties ("remaining units") or postpone the sale of the remaining units to such other date(s) and/or time(s) as the Vendor may consider appropriate. Details of the arrangement will be posted up by the Vendor. Visitors will not be notified separately of the arrangement. The Vendor's decision in this regard shall be final and binding on all persons.
