 - (b) On the First Day of Sale, a registrant (if the registrant is a corporation, then **all of its directors**) who preregistered for Part 2 of Session A and obtained a Session A2 Chop on the original receipt of Registration of
 Intent must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business
 Registration Certificate and documents filed with the Companies Registry showing the current list of director(s)
 and secretary, the original receipt of Registration of Intent and **personally** attend the ICC Venue according to
 the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 12 above. Registrant
 who arrives at the ICC Venue or (if directed by the Vendor) the Additional Venues (as defined below) beyond
