 - (d) The Vendor reserves the right to adjust the closing date and time of the tender by amending the relevant Information on Sales Arrangements relating to the specified residential property(ies). Any adjustment of the closing date and time of the tender will be posted at both the Sales Office (Admiralty Centre) and the Sales Office (8 Observatory Road).
