Registrant who intends to participate in a Part of Session A shall register on spot using his/her/their/its original receipt of Registration of Intent with the Vendor before commencement of that Part of Session A, provided that registrant who has already selected and purchased any specified residential property in a Part of Session A will not be allowed to participate in a subsequent Part of Session A.
- 8. Registrant who has not registered for a Part of Session A will **NOT** be allowed to participate in that Part of Session A.

第(III)部分 - 第 A 節的程序
