The sale of the specified residential properties will be divided into the following groups, namely Group AA and Group A. The individuals or companies interested in purchasing any of the specified residential properties are referred to below as the "Interested Party(ies)".

## Part (II) : Registration

- All Interested Parties (if the Interested Party is a company, then any one of its director) shall **personally** or by attorney pursuant to a validly executed power of attorney in a form prescribed by the Vendor attend the Sales Office at 2:00 p.m. on the First Date of Sale to participate in the selection of specified residential properties. Each Interested Party must bring along (if the Interested Party comprises individual(s)) his/her/their H.K.I.D. Card(s) or Passport(s) of each person comprising the Interested Party or (if the Interested Party is a company) copies of the valid Business Registration Certificate, Certificate of Incorporation, Certificate of Change of Name (if any) and the latest Annual Return of the registrant and the H.K.I.D. Card(s) or Passport(s) of the director(s) of the Interested Party who attend(s) the Sales Office; and (in the case of an attorney) H.K.I.D Card or Passport of the attorney, the original power of attorney and the copy of H.K.I.D Card(s) or Passport(s) of the relevant Interested Party.

- (a) Among Group AA Interested Party, higher priority in selection of specified residential properties will be given to a Group AA Interested Party with a greater Indicated Number. Where the Indicated Number of two or more Group AA Interested Parties are the same, first-come-first-served basis (based on their order of registration) will be used to determine the order of priority of selection of specified residential properties among such Group AA Interested Parties. In any circumstances where the procedure herein is not adhered to and in case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).

- (b) Group AA Unit Selection will commence at or after 2:00 p.m. at the Sales Office on the First Date of Sale. The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth sale of the specified residential properties, to adjust the time of the Group AA Unit Selection. Any changes to the time of the Group AA Unit Selection will be announced at the Sales Office. Interested Parties will not be notified separately of such changes.

##### **B. Procedures for Group A**

- (a) First-come-first-served basis (based on the order of registration) will be used to determine the order of priority of selection of specified residential properties among all Group A Interested Parties. In any circumstances where the procedure herein is not adhered to and in case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).

The Vendor reserves the right at any time, for the purposes of maintaining order at the Sales Office and/or facilitating smooth sale of the specified residential properties, to adjust the time of the Group A Unit Selection. Any changes to the time of the Group A Unit Selection will be announced at the Sales Office. Interested Parties will not be notified separately of such changes.

## 2. Restrictions on addition of “family member(s)” of the Interested Party(ies) as purchaser

- (a) If the Interested Party comprises individual(s) and purchases **one (1)** specified residential property: before signing the preliminary agreement for sale and purchase, the interested party may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the family member(s) of **ONE OF** the individual(s) comprised in the Interested Party and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.

- (b) If the Interested Party comprises individual(s) and purchases **two (2) or more** specified residential properties :-

- (i) Before signing the preliminary agreement for sale and purchase in respect of the first specified residential property, the Interested Party may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the family member(s) of **ONE OF** the individual(s) comprised in the Interested Party and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.

- (d) For the purpose of these Sales Arrangements, “**family member**” of an individual means a spouse, parent, child, parent-in-law, child-in-law, brother-in-law, sister-in-law, grandparent, grandchild, sibling, parent's sibling, cousin, nephew or niece of that individual.

- (e) The Vendor reserves its absolute discretion to allow or reject the Interested Party's request to add and/or delete any individual(s).

If an Interested Party who has selected any one or more specified residential property(ies) on the First Date of Sale, but for whatever reason is/are unable or refuse to sign preliminary agreement for sale and purchase of any one of the selected specified residential properties, it will be deemed that the said Interested Party has given up the right to select and purchase any specified residential property(ies). In such event, such Interested Party will not be eligible to select any of the specified residential properties in the relevant time for Unit Selection on the First Date of Sale.

### **Batch 1**

#### **1. Arrangements for viewing of properties on or before the First Date of Sale**

**於出售首日或之前參觀物業之安排**

Subject to any other arrangements by the Vendor from time to time, prior to the First Date of Sale, the specified residential properties or their comparable residential properties (if viewing of the specified residential properties is not reasonably practicable) will be made available for viewing by all Interested Parties between 3:00 p.m. and 6:00 p.m. on 1 November 2024. All Interested Parties are offered and advised to view the specified residential property(ies) which they intend to purchase or its/their comparable residential property(ies) (if viewing of the specified residential property(ies) is not reasonably practicable) during the aforesaid period **before attending the Sales Office for selection of any of the specified residential property(ies)**. For the purpose of maintaining order at the Sales Office and ensuring the smoothness of the selection procedures, on the First Date of Sale, after an Interested Party has selected specified residential property(ies), such Interested Party will be requested to proceed with the signing of the preliminary agreement(s) for sale and purchase of the specified residential property(ies) selected. The specified residential property(ies) selected will not be reserved for any Interested Party during his/her/their viewing of such specified residential property(ies) or its/their comparable residential property(ies) (if viewing of the specified residential property(ies) is not reasonably practicable)

after selection and before signing of the preliminary agreement(s) for sale and purchase. Due to manpower arrangements, it may not be reasonably practicable for the Vendor to arrange viewing of any specified residential property or its comparable residential property by Interested Party(ies) on the First Date of Sale. All Interested Parties are therefore advised to make prior arrangements with the Vendor for viewing of specified residential property(ies) or its/their comparable residential property(ies) (if viewing of the specified residential property(ies) is not reasonably practicable) prior to the First Date of Sale.

For safety and maintenance of order at the Sales Office, the Vendor reserves its absolute right to, in the case where a Typhoon Signal No.8 or above or Black Rainstorm Warning is in effect in Hong Kong, or where the Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the Sales Office and/or its vicinity, postpone, extend or modify the date, time, period or place of sale to such other date, time, period or place as the Vendor may consider appropriate. Details will be announced on the website of the Phase of the Development and persons interested in purchasing specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
