- (a) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending and/or issuing the Sales Arrangements.

- (b) Notwithstanding anything herein provided, if Tropical Cyclone Warning Signal No. 8 or above or Black Rainstorm Warning Signal or “Extreme Condition” is in effect in Hong Kong at any time from 12:00 noon to 2:00 p.m. on the day on which the closing time of the tender falls, the closing time of the tender will automatically be postponed to 2:00 p.m. on the next succeeding day in respect of which no Typhoon Signal No.8 or above is hoisted or Black Rainstorm Warning or “Extreme Condition” is in effect in Hong Kong at any time from 12:00 noon to 2:00 p.m.. For safety and maintenance of order at the Designated Venue, the Vendor reserves its absolute right to, in the case where the Vendor considers that there being any event or circumstance affecting or which may affect the safety, order or public health in the Designated Venue and/or its vicinity, postpone, extend or modify the date, time, period, place of sale or selection of specified residential properties or other procedures to such other date, time, period or place as the Vendor may consider appropriate. Details will be announced on the website of the Development and persons interested in purchasing the specified residential properties will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Designated Venue. The Vendor's decision in this regard shall be final and binding on all persons.

即使本銷售安排資料另有規定，如在招標截止時間當日中午 12 時至下午 2 時內的任何時間，8 號或以上颱風訊號或黑色暴雨警告在香港生效，招標截止時間將自動順延至下一個緊接該日並在中午 12 時至下午 2 時之間並無懸掛 8 號或以上颱風訊號或發出黑色暴雨警告訊號之日子之下午 2 時。為保障安全及維持指定會場秩序，賣方保留絕對權力當賣方認為出現任何影響或可能影響指定會場及/或其附近之安全、秩序、或公共衛生之事件或情況時，延後、延長或改動發售或揀選指明住宅物業或其他程序之日期、時間、期間或地點至賣方認為合適的其他日期、時間、期間或地點，詳情於發展項目網站公布，意欲購買指明住宅物業之人士將不獲另行通知。賣方保留權利拒絕任何人士進入指定會場。賣方此方面所作的決定為最終決定，對所有人士具有約束力。

Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender after the close of that previous tender exercise.
