Section I - General Procedures

第I部份 - 一般程序

1. **Sale by Tender.** See details and particulars in the tender notice. During the tender periods, the tender notice and other relevant tender documents will be made available for collection free of charge at the Sales Office from 11:00 a.m. to 6:00 p.m. daily. The Vendor has the absolute right to revise the tender notice, the tender documents and the annexes from time to time without informing tenderers individually. The Vendor advises tenderers to check and ensure before submission of tender that the latest version of the tender notice, tender documents and annexes has been used.

The Vendor has absolute right to change the closing date and/or time of the tender in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.

The Vendor reserves the right to reject the entry of any person into the Sales Office. The Vendor's decision in this regard shall be final and binding on all persons.
