#### **Sale by Tender – see details and particulars in the tender notice**

- (a) Please refer to the tender notice and other relevant tender documents for details and particulars. From 28 December 2021 to ~~30 June 2022~~ 31 December 2022 (from 10:00 a.m. to 5:00 p.m. daily except Saturday, Sunday and public holidays), the tender notice and other relevant tender documents will be made available for collection free of charge at (i) Sales Office (Villa La Plage) or (ii) Sales Office (Admiralty Centre) (collectively, “the Location of Tender Box”).
- (b) For the safety of interested persons and maintenance of order at the Sales Office or for the compliance with any restriction imposed or any order issued by the Hong Kong Government relating to Coronavirus Disease 2019 (“COVID-19”) and/or for implementing the Compulsory Universal Testing (CUT) Scheme, the Vendor reserves its absolute right to, in the case where the Vendor considers that there being an event affecting the safety, order or public health in the Sales Office and/or its vicinity; or where during the enforcement of any restriction imposed or any order issued by the Hong Kong Government relating to COVID-19 and/or for implementing the CUT Scheme which requires people in Hong Kong (except for exempted persons) to stay indoor (such as stay-at-home, movement control or lockdown orders), postpone and/or modify the date, time, period and/or place of sale to such other date, time, period and/or place as the Vendor may consider appropriate. Details of the arrangement will be posted by the Vendor on the website designated by the Vendor for the Development ([www.villalaplage.hk](http://www.villalaplage.hk)). Interested persons will not be separately notified of the same.
- (c) (i) In case a black rainstorm warning signal or a typhoon signal no.8 or above is announced or is still in effect after 12:00 p.m. on the closing date of the tender, the closing date of the tender will be extended to the next day (5:00 p.m.) which is not a Saturday, Sunday or public holiday and in respect of which no black rainstorm warning signal or typhoon signal no.8 or above is announced.
- (ii) In case any restriction imposed or any order issued by the Hong Kong Government relating to COVID-19 and/or for implementing the CUT Scheme which requires people in Hong Kong (except for exempted persons) to stay indoor (such as stay-at-home, movement control or lockdown order) is enforced after 12:00 p.m. on the closing date of the tender, the closing date of the tender will be extended to the next day (5:00 p.m.) which is not a Saturday, Sunday or public holiday and in respect of which no such restriction or order relating to COVID-19 and/or for implementing the CUT Scheme is enforced after 12:00 p.m.
- (iii) For the safety of the tenderers and the maintenance of order at the Location of Tender Box, the Vendor reserves its absolute right to close the Location of Tender Box without prior notice. Details of the arrangement will be posted by the Vendor on the website designated by the Vendor for the Development ([www.villalaplage.hk](http://www.villalaplage.hk)).

- (a) 細節和詳情請參閱招標公告及其他相關招標文件。由 2021 年 12 月 28 日起至 ~~2022 年 6 月 30 日~~ 2022 年 12 月 31 日(每日上午 10 時至下午 5 時，星期六、星期日及公眾假期除外)，招標公告及其他招標文件可於(i)售樓處(臻譽)或(ii)售樓處(海富中心)免費領取(統稱「投標箱地點」)。
- (b) 為保障有意欲購買的人士安全及維持售樓處秩序或為遵從香港政府就有關 2019 冠狀病毒病(「COVID-19」)及/或實施全民強制檢測(「全民強檢」)計劃而施加或發出的限制或命令，當賣方認為發生影響售樓處及/或其附近之安全、秩序或公共衛生之事件時，或香港政府就有關 COVID-19 及/或實施全民強檢計劃而執行所施加或發出任何限制或命令要求在香港的人士(獲豁免人士除外)留在室內(例如居家、活動管制或禁足令)時，賣方保留絕對權利延後及/或改動發售之日期、時間、期間及/或地點至賣方認為合適的其他日期、時間、期間及/或地點。賣方會將安排的詳情於賣方為發展項目指定的互聯網網站的網址([www.villalaplage.hk](http://www.villalaplage.hk))公布。有意欲購買的人士將不獲另行通知。

- (a) The Vendor does not undertake and is under no obligation to review, consider or accept the highest tender or any tender at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any tender. The Vendor has the absolute right to accept any tender at or before the tender closing date and/or time. The Vendor has absolute right to change the tender closing date and/or time in respect of all or any of the specified residential properties from time to time by amending and/or issuing Sales Arrangements.
- (b) Persons interested in submitting tenders of the specified residential properties are reminded to examine the latest register of transactions of the Development so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within the acceptance period after the tender closing date of that previous tender exercise.
- (c) Please note that entry of any person into the Location of Tender Box will be subject to satisfactory check of **normal** body temperature on-site. Any person entering into the Location of Tender Box is required to wear a self-provided **satisfactory** surgical face mask at all times while at the Location of Tender Box. No face mask will be provided by the Vendor on-site. The Vendor reserves the absolute right and discretion to determine whether a person's body temperature is "normal" or "satisfactory" and whether a person's surgical face mask is of "satisfactory" standard, and to deny entry of any person who fails to meet the aforesaid requirements. The Vendor's decision in this regard shall be final and binding on all persons.
- (a) 賣方並不承諾亦無責任閱覽、考慮或接受認購任何指明住宅物業出價最高的投標書或任何一份投標書。賣方有絕對權利於接受任何投標書前於任何時間撤回出售任何指明住宅物業。賣方有絕對權利於招標截止日期及/或時間或之前接受任何投標書。賣方有全權透過修改及/或發出銷售安排不時更改全部或任何指明住宅物業的招標日期及/或時間。
