  - (c) The Vendor reserves the right to, at any time before acceptance of a tender, withdraw any specified residential property from sale or to sell or dispose of any specified residential property to any person by any method (including, without limitation, private treaty, tender and auction).
  - (d) The Vendor reserves the right to adjust the closing date and time of the tender by amending the relevant Information on Sales Arrangements relating to the specified residential property(ies). Any adjustment of the closing date and time of the tender will be posted at both the Sales Office (Admiralty Centre) and the Sales Office (8 Observatory Road). The Vendor is not obliged to separately notify the Tenderers of such adjustment.
