1. General provisions:

1.1. Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

2. Subject to the provisions set out in “Other matters” below, first come first served. Persons interested in purchasing any specified residential property(ies) must attend the Sales Venue in person or by attorney pursuant to a validly executed power of attorney to select the residential property(ies) that the person wishes to purchase. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

The Vendor may have sold a specified residential property under any previous sales arrangements in which case that specified residential property would become not available for selection hereunder.

Details will be announced on the website of the Phase of the Development ([www.lemont.com.hk](http://www.lemont.com.hk)) and interested persons will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Venue. The Vendor's decision in this regard shall be final and binding on all persons.
