On the First Day of Sale

Section (I) - Abstract

1. Prior to the commencement of Session A, eligible staff within Sun Hung Kai Properties Group (“**Staff Registrants**”) and their eligible family members may select and purchase the specified residential properties as set out above. Staff Registrants and their eligible family members must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), the original receipt of Staff Registration of Intent and personally attend the ICC 11/F Venue from 8:30 a.m. to 8:45 a.m.. Staff Registrants and their eligible family members who arrive at the ICC 11/F Venue after 8:45 a.m. shall not be eligible to participate in the selection and purchase of the specified residential properties. After verification of the identity of the Staff Registrants and their eligible family members by the Vendor, the order of priority in which the Staff Registrants shall select and purchase a specified residential property shall be determined by the length of service of the Staff Registrants (in descending order) as determined by the Vendor whose determination shall be final and absolute. Each Staff Registrant and their eligible family members may purchase not more than one (1) specified residential property.
2. After the selection of specified residential properties by the Staff Registrants, other registrants shall proceed to select and purchase the specified residential properties in accordance with the sales procedures below.
3. The sale of the specified residential properties will be divided into the following 2 sessions (namely Session A and Session B).

Section (II) - Submission of Registration of Intent for Session A and Session B before the First Day of Sale

4. Any person interested in purchasing any of the specified residential properties (the “**registrant**”) must follow the procedures below. A registrant who wishes to participate in Session A (“**Session A registrant**”) shall submit Registration of Intent (Form A). A registrant who wishes to participate in Session B (“**Session B registrant**”) shall submit Registration of Intent (Form B).
5. A registrant (if the registrant is a corporation, then **any one of its directors**) must **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) submit the following:-
 - (a) only one Registration of Intent duly completed and signed by the registrant;
 - (b) the Registration of Intent shall be accompanied with cashier order(s) each in the sum of HK\$50,000 and made payable to “**JOHNSON STOKES & MASTER**”. The number of cashier order(s) shall be equal to the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent;
 - (c) a copy of the registrant’s H.K.I.D. Card(s)/Passport(s) and (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary

to the ICC 11/F Venue after the relevant price list(s) of the specified residential properties are made available till 16 May 2025 (both dates inclusive) during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday). The closing time for submission of Registration of Intent will be 8:00 p.m. on 16 May 2025 (the “**deadline**”). Late submission or submission outside the office hours will not be accepted. Upon completion of the procedures stated in this paragraph, the registrant will be given a receipt of Registration of Intent.
6. For the avoidance of doubt, all valid Registration(s) of Intent submitted on or before 12 May 2025 (if any), subject to the provisions below, will be included in the sales procedures under this Information on Sales Arrangements :-
 - (a) If a Session A registrant of such valid Registration of Intent (Form A) has pre-registered such valid Registration of Intent (Form A) during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday) and before the deadline set out in paragraph 5 above at ICC 11/F Venue in accordance with the procedures set out by the Vendor, such Session A registrant shall be

entitled to participate in (subject to compliance with sales procedures in Section (III)) Part G (including Super AG) or Part 3 of Session A.

- (b) Otherwise, the Session A registrant(s) of such valid Registration(s) of Intent (Form A) will be included in Part 4 of Session A for the purpose of balloting and the order of priority of such Session A registrant(s) will be determined by a balloting for such Part 4 of Session A in accordance with paragraphs 10 and 12 below. For the avoidance of doubt, such Session A registrant(s) shall not be entitled to pre-register and participate in Part G and Part 3 of Session A.
- (c) If a Session B registrant of such valid Registration of Intent (Form B) has “renewed” such valid Registration of Intent (Form B) during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday) and before the deadline set out in paragraph 5 above at ICC 11/F Venue in accordance with the procedures set out by the Vendor, such Session B registrant will be included in the *first sub-group* or the *second sub-group* of Session B (as the case may be) for the purpose of balloting and the order of priority of such Session B registrant will be determined by a balloting for that sub-group in accordance with paragraphs 10 and 12 below.
- (d) Otherwise, the Session B registrant(s) of such valid Registration(s) of Intent (Form B) will be included in the *third sub-group* or the *fourth sub-group* of Session B (as the case may be) for the purpose of balloting and the order of priority of such Session B registrant(s) will be determined by a balloting for that sub-group in accordance with paragraphs 10 and 12 below.

Valid Registration(s) of Intent mean those Registration(s) of Intent (a) which has/have not been used to purchase any specified residential property(ies) in accordance with any previous Information on Sales Arrangements; (b) the registrant(s) has not collected the unused cashier order(s) in accordance with any Information on Sales Arrangements; and (c) which has/have not been declared by the Vendor to be invalid. The Vendor hereby declares that all Registrations of Intent which have been used to purchase specified residential property(ies) in accordance with any previous Information on Sales Arrangements (whether they still have unused cashier order(s) submitted with them or not) to be invalid. In case of dispute, the Vendor has the absolute right to determine whether a Registration of Intent shall be included in the sales procedures under this Information on Sales Arrangements.

Section (III) – Pre-registration for Part G and Part 3 of Session A before the First Day of Sale

- 7. (a) A Session A registrant may only pre-register for one Part of Session A.
- (b) Only Session A registrant who has completed pre-registration for Part G of Session A may participate in Super AG and/or Part G of Session A.
- (c) Only Session A registrant who has completed pre-registration for Part 3 of Session A may participate in Part 3 of Session A.
- (d) A Session A registrant who has not completed pre-registration for any Part of Session A may only participate in Part 4 of Session A.

8. Pre-registration for Part G of Session A before the First Day of Sale

- (a) A Session A registrant interested in participating in Part G of Session A (if the Session A registrant is a corporation, then **any one of its directors**) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC 11/F Venue during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday) and before the deadline set out in paragraph 5 above to register to participate in Part G of Session A. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session AG Chop**”), to signify the completion of pre-registration of Part G of Session A by the Session A registrant.
- (b) Only Session A registrants who have pre-registered to participate in Part G of Session A in accordance with paragraph 8 and who have obtained a Session AG Chop on its original receipt of Registration of Intent may participate in Part G of Session A.

9. Pre-registration for Part 3 of Session A before the First Day of Sale

- (a) A Session A registrant interested in participating in Part 3 of Session A (if the Session A registrant is a corporation, then **any one of its directors**) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s),

(if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** (or (subject to the approval of the Vendor in its absolute discretion on a case by case basis) by his/her/their/its agent) attend the ICC 11/F Venue during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday) and before the deadline set out in paragraph 5 above to register to participate in Part 3 of Session A. Upon completion of the procedures stated in this paragraph, the original receipt of Registration of Intent of the registrant will be chopped with a chop (the “**Session A3 Chop**”), to signify the completion of pre-registration of Part 3 of Session A by the Session A registrant.

- (b) Only Session A registrants who have pre-registered to participate in Part 3 of Session A in accordance with paragraph 9 and who have obtained a Session A3 Chop on its original receipt of Registration of Intent may participate in Part 3 of Session A.

Section (IV) – Balloting for Session A and Session B before the First Day of Sale

10. Separate balloting will be used to determine the order of priority in selecting the specified residential properties in Part G, Part 3 and Part 4 of Session A and Session B respectively :-
 - (a) For each Part of Session A, a first round balloting will be carried out to divide the registrants into one or more group(s) and a second round balloting will be carried out to determine each registrant's "ballot result sequence" at ICC 11/F Venue on 17 May 2025.
 - (b) For Session B, a first round balloting will be carried out to divide the registrants into one or more group(s) and a second round balloting will be carried out to determine each registrant's "ballot result sequence" at ICC 11/F Venue on 17 May 2025.
11. The Vendor reserves the right at any time, for the purposes of maintaining order at the ICC 11/F Venue and/or facilitating smooth balloting and/or due to the reasons set out in paragraphs 36 and 37 below, to adjust the date, time and location of the balloting. Any changes to the date, time and location of the balloting will be posted at the ICC 11/F Venue and at the ICC Lobby. Registrants will not be notified separately of such changes.
12.
 - (a) Before the balloting for Part G, Part 3 and Part 4 of Session A takes place respectively, the registrants in each of Part G, Part 3 and Part 4 of Session A shall be further divided into two sub-groups: the first sub-group consists of registrants comprising individual(s) only; and the second sub-group consists of the remaining registrants. **Registrants in the first sub-group will have priority over the registrants in the second sub-group in the selection of the specified residential properties in each of Part G, Part 3 and Part 4 of Session A.** The Vendor shall carry out the balloting for each sub-group respectively.
 - (b) Before the balloting for Session B takes place, the registrants in Session B shall be further divided into four sub-groups: the first sub-group consists of registrants comprising individual(s) only and who have submitted Registration of Intent (Form B) in accordance with the procedures in Section (II) or who have “renewed” the Registration of Intent (Form B) in accordance with paragraph 6(c) above; the second sub-group consists of the remaining registrants who have submitted Registration of Intent (Form B) in accordance with the procedures in Section (II) or who have “renewed” the Registration of Intent (Form B) in accordance with paragraph 6(c) above; the third sub-group consists of the remaining registrants comprising individual(s) only; and the fourth sub-group consists of the remaining registrants. **Registrants in the first sub-group will have priority over the registrants in the second sub-group, registrants in the second sub-group will have priority over the registrants in the third sub-group, and registrants in the third sub-group will have priority over the registrants in the fourth sub-group in the selection of the specified residential properties in Session B.** The Vendor shall carry out the balloting for each sub-group respectively.

 - (a) In respect of Part G of Session A, every valid Registration of Intent shall be allotted one lot.
 - (b) In respect of Part 3 of Session A, every valid Registration of Intent shall be allotted one lot.
 - (c) In respect of Part 4 of Session A, every valid Registration of Intent shall be allotted one lot.
 - (d) In respect of Session B, every valid Registration of Intent shall be allotted one lot.
14. The results of the balloting, including “registration number”, “ballot result sequence” and "check-in timeslot" for Part G, Part 3 and Part 4 of Session A and Session B will be announced and/or posted up at the ICC 11/F Venue and (if applicable) the ICC Lobby and on the on the website (www.sierrasea1b.com.hk) designated by the Vendor for the Phase (“**Designated Website**”) after 12:00 p.m. on 17 May 2025. Registrants will not be separately notified of the ballot results.

Section (V) - Procedures for Session A on the First Day of Sale

15. Session A registrants must follow the procedures specified in Sections (I), (II), (III) (if applicable), (IV), (V) and (VII).
- (a) On the First Day of Sale, a registrant who pre-registered for Part G of Session A (if the registrant is a corporation, then **any one of its directors** or if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues according to the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 14 above. Registrant who arrives at the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part G of Session A.
 - (b) On the First Day of Sale, a registrant who pre-registered for Part 3 of Session A (if the registrant is a corporation, then **any one of its directors** or if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues according to the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 14 above. Registrant who arrives at the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part 3 of Session A.
 - (c) On the First Day of Sale, a registrant who participates in Part 4 of Session A (if the registrant is a corporation, then **any one of its directors** or if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary, the original receipt of Registration of Intent and **personally** attend the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues according to the "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 14 above. Registrant who arrives at the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues beyond his/her/its/their "check-in timeslot" shall not be eligible for participating in Part 4 of Session A.
 - (d) In case the ICC 11/F Venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason direct the registrants to attend the ICC Lobby and/or the lobby on 8/F and/or the lobby on 9/F and/or 10/F and/or 16/F and/or Unit Nos. 1901A and 1908, 19/F and/or 21/F of International Commerce Centre, No. 1 Austin Road West, Kowloon, Hong Kong (collectively the "**Additional Venues**") by making announcement at the ICC 11/F Venue and the Additional Venues.
16. After verification of the identity of registrants by the Vendor, Session A will be proceeded in 4 parts and, subject to paragraph 22 below, in the following order, namely, Super AG, Part G, Part 3 and Part 4.

21. For each specified residential property purchased by the registrant, part of preliminary deposit in the following sum shall be paid by cashier order(s) :-
- (a) HK\$450,000 for each specified residential property which is 3-bedroom unit (the saleable area of which is not less than 800 sq. ft.);

 - (e) HK\$150,000 for each specified residential property which is 2-bedroom unit (without store room); and
 - (f) HK\$100,000 for each other specified residential property.

In addition to using one cashier order submitted with the Registration of Intent for each specified residential property purchased by the registrant, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s) made payable to "**JOHNSON STOKES & MASTER**" for payment of part of preliminary deposit of the specified residential property(ies) as stated above.

If the number of specified residential properties the registrant purchases exceeds the number of cashier orders submitted with the Registration of Intent, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s) made payable to "**JOHNSON STOKES & MASTER**" for payment of part of preliminary deposit of each extra specified residential property as stated above.

22. If the remaining specified residential properties available for selection and purchase in Super AG or a Part of Session A is such that the rules for Super AG or that Part of Session A as set out in the Abstract in Section (I) cannot be satisfied, then:-
- (a) (in the case of Super AG of Session A) Super AG of Session A will end and the remaining Session Super AG Units will be offered for sale in Part G of Sessions A;
 - (b) (in the case of Part G of Session A) Part G of Session A will end and the remaining Session Super AG Units and Session AG Units will be offered for sale in Part 3 of Session A;
 - (c) (in the case of Part 3 of Session A) Part 3 of Session A will end and the remaining Session Super AG Units, Session AG Units and Session A3 Units will be offered for sale in Part 4 of Session A; and
 - (d) (in the case of Part 4 of Session A) Part 4 of Session A will end and the remaining Session Super AG Units, Session AG Units and Session A3 Units will be offered for sale in Session B.
23. A registrant who leaves the ICC 11/F Venue and/or (if applicable) the Additional Venues while his/her/their/its group is in session for selecting and purchasing specified residential properties shall be disqualified for participating in the selection and purchase of specified residential properties in Super AG or that Part of Session A and his/her/their/its order of priority in Super AG or that Part of Session A shall lapse immediately.
24. If a registrant has successfully selected the specified residential property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant (if the registrant is a corporation, then **any one of its directors** or, if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a

form prescribed by the Vendor) shall **personally** enter into one or more preliminary agreement(s) for sale and purchase of the selected specified residential property(ies). If the registrant does not enter into all preliminary agreement(s) for sale and purchase of all the selected specified residential properties, he/she/they/it would be deemed to have given up those specified residential properties and his/her/their/its order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in Super AG or that Part of Session A.

25. Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential properties, a registrant may request the Vendor on spot to add his/her **close relative(s)** (as defined in paragraph 33(a) below) as joint purchasers and/or delete the registrant's name from the preliminary agreement(s) for sale and purchase in accordance with the requirements specified under paragraph 33 below.

Section (VI) - Procedures for Session B on the First Day of Sale

26. Session B registrants must follow the procedures specified in Sections (I), (II), (IV), (VI) and (VII).
27. (a) On the First Day of Sale, the registrants (if the registrant is a corporation, then **any one of its directors**) must bring along his/her/their original H.K.I.D. Card(s)/Passport(s), (if applicable) copy of Business Registration Certificate and documents filed with the Companies Registry showing the current list of director(s) and secretary and the original receipt of Registration of Intent and **personally** (or, if the registrant is or comprise individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) attend the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues according to "check-in timeslot" announced and/or posted by the Vendor pursuant to paragraph 14 above. Registrants who arrive at the ICC 11/F Venue or (if directed by the Vendor) the Additional Venues beyond their "check-in timeslot" shall not be eligible to participate in Session B.
- (b) In case the ICC 11/F Venue shall become insufficient to accommodate all the registrants, the Vendor may for safety reason, make use of the Additional Venues to accommodate some of the registrants by making announcement and/or posting notice(s) at the ICC 11/F Venue and the Additional Venues.
28. A registrant who leaves the ICC 11/F Venue and/or (if applicable) the Additional Venues while his/her/their/its group is in session for selecting and purchasing specified residential properties shall be disqualified for participating in Session B and his/her/their/its order of priority shall lapse immediately.
29. The selection and purchase of the specified residential properties in Session B shall only commence **after** Session A has been completed. The Vendor may postpone the time for selection and purchase of the specified residential properties in Session B pending completion of Session A. Registrants shall proceed to select the specified residential properties in accordance with the rules below :-
- (a) Registrants (if the registrant is a corporation, then **any one of its directors** or, if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) shall **personally** select the specified residential properties which are still available at the time of selection in the order of priority according to the "ballot result sequence" and in an orderly manner and within reasonable time. Registrants shall select and purchase the specified residential properties **in compliance with the rules set out in Section (I) applicable to Session B**, and purchase all the specified residential properties selected by him/her/they/it, otherwise such registrant's order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in Session B.
- (b) For each specified residential property purchased by the registrant, part of preliminary deposit in the following sum shall be paid by cashier order(s) :-
- (i) HK\$450,000 for each specified residential property which is 3-bedroom unit (the saleable area of which is not less than 800 sq. ft.);

- (vi) HK\$100,000 for each other specified residential property.

In addition to using one cashier order submitted with the Registration of Intent for each specified residential property purchased by the registrant, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s) made payable to “**JOHNSON STOKES & MASTER**” for payment of part of preliminary deposit of the specified residential property(ies) as stated above.

If the number of specified residential properties the registrant purchases in exceeds the number of cashier orders submitted with the Registration of Intent, the registrant shall submit on spot to the Vendor sufficient additional cashier order(s) made payable to “**JOHNSON STOKES & MASTER**” for payment of part of preliminary deposit of each extra specified residential property as stated above.

- (c) If a registrant has successfully selected the specified residential property(ies) in compliance with the rules set out in the Abstract in Section (I), the registrant (if the registrant is a corporation, then **any one of its directors** or, if the registrant is or comprises individual(s), by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) shall **personally** enter into one or more preliminary agreement(s) for sale and purchase of the selected specified residential property(ies). If the registrant does not enter into all preliminary agreement(s) for sale and purchase of all the selected specified residential properties, he/she/they/it would be deemed to have given up those specified residential properties and his/her/their order of priority shall lapse automatically and he/she/they/it will no longer be eligible to participate in Session B.
- (d) Before entering into the preliminary agreement(s) for sale and purchase in respect of the selected specified residential property(ies), the registrant may request the Vendor on spot to add his/her **close relative(s)** as joint purchaser(s) (but not to delete the registrant’s name from the preliminary agreement(s) for sale and purchase) in accordance with the requirements under paragraph 33 below.

Section (VII) - General Provisions (applicable to both Session A and Session B)

30. The following apply to registration:-

- (a) Each individual or corporation (whether alone or jointly with others) shall only be registered under one valid Registration of Intent (Form A) and one valid Registration of Intent (Form B). Duplicated registration will not be accepted.
- (b) The Registration of Intent is personal to the registrant and shall not be transferable.
- (c) The order of submission of the Registration of Intent and the order of pre-registration to participate Part G and/or Part 3 of Session A will not have any impact on the order of priority for selecting the specified residential properties in Super AG, Part G, Part 3 and Part 4 of Session A and Session B.
- (d) (For corporate registrant) If after the submission of Registration of Intent, there is any change in the composition of the board of directors of the corporation, then the relevant Registration of Intent shall become invalid immediately and the registrant **shall not be eligible to participate in any Session.**
- (e) In case of dispute, the Vendor reserves its right to determine whether a registrant is eligible to participate in Super AG and/or any Part of Session A and/or Session B and whether a Registration of Intent is valid and should be included in balloting.

31. Arrangements on cashier order(s):-

- (a) The cashier order(s) submitted will be used as part payment of the preliminary deposit for the purchase of the specified residential property(ies). Unless otherwise specified in this Sales Arrangements, the balance of the preliminary deposit for the purchase of the specified residential property(ies) may be paid by personal cheque(s) upon signing of the preliminary agreement for sale and purchase.
- (b) If a registrant has not purchased any specified residential property or the number of specified residential property(ies) being purchased is less than the number of specified residential property(ies) which the registrant intends to purchase as indicated in the Registration of Intent, the unused cashier order(s) will be available for collection by the registrant (or his/her/their/its authorized person) at the ICC 11/F Venue from 1 June 2025 to 7 June 2025 (both days inclusive) during office hours (i.e. from 2:00 p.m. to 8:00 p.m. on Monday to Friday and from 11:00 a.m. to 8:00 p.m. on Saturday, Sunday and Public Holiday). The Vendor reserves the right to adjust from time to time the date, time and venue for collection of the unused cashier order(s) without further notice to the registrant. The registrant must bring along his/her/their H.K.I.D. Card(s)/Passport(s) (or a copy of the H.K.I.D. Card(s)/Passport(s) of the registrant if unused cashier order(s) is/are collected by authorized person), (if applicable) copy of Business Registration Certificate, the original receipt(s) of Registration of Intent and (if applicable) a valid authorization letter and a copy of the H.K.I.D. Card/Passport of the authorized person.

32. The Vendor shall not be responsible to the registrants for any error or omission contained in the ballot results.

33. The following apply to addition of “close relative(s)” of the registrant(s) as purchaser and/or delete the registrant’s name from the preliminary agreement(s) for sale and purchase :-
- (a) “**close relative(s)**” means spouse, parents, spouse’s parents, children, brothers, sisters, grandparents and grandchildren of the registrant.
 - (b) If the registrant comprises individual(s) and purchases **one (1)** specified residential property: before signing the preliminary agreement for sale and purchase, such registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (c) If the registrant comprises individual(s) and purchases **two (2) or more** specified residential properties and the registrants requests to have **one (1) preliminary agreement for sale and purchase** for all those properties: before signing the preliminary agreement for sale and purchase, the registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (d) If the registrant comprises individual(s) and purchases **two (2) or more** specified residential properties and the registrants requests to have **more than one (1) preliminary agreement for sale and purchase** for those properties:-
 - (i) Before signing the preliminary agreement for sale and purchase in respect of the **first** specified residential property, a registrant may request the Vendor on spot to add the name(s) of individual(s) to sign the preliminary agreement for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (ii) Before signing the preliminary agreement for sale and purchase in respect of the **subsequent** specified residential property(ies), a registrant may request the Vendor on spot to:-
 - (1) add the name(s) of individual(s) to sign the preliminary agreement(s) for sale and purchase as joint purchasers, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final; or
 - (2) add the name(s) of individual(s) to sign the preliminary agreement(s) for sale and purchase as purchaser(s), and delete the registrant’s name from the preliminary agreement(s) for sale and purchase, provided that the additional individual(s) must be the close relative(s) of **ALL** the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor’s satisfaction whose determination shall be final.
 - (e) All the person(s) signing the preliminary agreement for sale and purchase must sign personally (or by attorney of such individual(s) pursuant to a validly executed power of attorney in a form prescribed by the Vendor) as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant’s request to add and/or delete any individual(s).
34. After the completion of the balloting and selection of the specified residential properties by the eligible persons in accordance with the above procedures, the remaining specified residential properties (if any) will be offered to be sold on a first come first served basis to any person interested in purchasing the remaining specified residential properties. In case of any dispute, the Vendor reserves its absolute right to allocate any remaining specified residential properties to any person interested in purchasing by any method (including balloting). For the avoidance of doubt, there is no restriction on the number of specified residential properties that a purchaser (whether individual or corporation) may purchase on a first come first served basis.
35. The Vendor reserves the right to close the ICC 11/F Venue and/or (if applicable) the Additional Venues at any time if all the specified residential properties have been sold out.
36. If Typhoon Signal No. 8 or above is hoisted or Black Rainstorm Warning is issued at any time on any date on which the Registration of Intent may be submitted, or pre-registration shall be completed or balloting shall take place and/or the First Day of Sale and/or any other date of sale, then, for the safety of the registrants and the maintenance of order at the

ICC 11/F Venue and/or (if applicable) the Additional Venues, the Vendor reserves its absolute right to (a) change the date(s) and/or time(s) and/or location(s) of (i) submission of Registration of Intent and/or (ii) the pre-registration and/or (iii) the balloting for Super AG and/or any Part of Session A and/or Session B and/or (iv) the check-in timeslot for Super AG and/or any Part of Session A and/or (v) the check-in timeslot for Session B and/or (vi) the First Day of Sale and/or any other date of sale as the Vendor may consider appropriate and/or (b) close the ICC 11/F Venue and/or (if applicable) the Additional Venues. Details of the arrangement will be posted by the Vendor on the Designated Website. Registrants will not be notified separately of the arrangement.

37. The Vendor reserves the right at any time, (I) for the purpose of maintaining security and order at the ICC 11/F Venue and/or (if applicable) the Additional Venues, safety of the registrants and/or smooth operation of the sales procedures and/or (II) due to disrupted access to the ICC 11/F Venue and/or (if applicable) the Additional Venues and/or (III) where there is any event or circumstance affecting or which may affect the safety, order or public health in the ICC 11/F Venue and/or (if applicable) the Additional Venues and/or (IV) for the purpose of protecting the health of the registrants and other participants in the ICC 11/F Venue and/or (if applicable) the Additional Venues, to:-
- (a) (prior to the First Day of Sale and/or commencement of sale of the specified residential properties on a day) (i) change the date(s) and/or time(s) and/or location(s) of (1) submission of Registration of Intent and/or (2) the pre-registration and/or (3) the balloting for Super AG and/or any Part of Session A and/or Session B and/or (4) the check-in timeslot for Super AG and/or any Part of Session A and/or (5) the check-in timeslot for Session B and/or (6) the First Day of Sale and/or any other date of sale and/or any sales procedures as the Vendor may consider appropriate and/or (ii) to close the ICC 11/F Venue and/or (if applicable) the Additional Venues. Details of the arrangement will be posted up by the Vendor at the ICC 11/F Venue and/or on the Designated Website. Registrants will not be notified separately of the arrangement; and
 - (b) (during the sale of the specified residential properties on a day) suspend the sale of all the remaining unsold specified residential properties ("**remaining units**") or postpone the sale of the remaining units to such other date(s) and/or time(s) as the Vendor may consider appropriate. Details of the arrangement will be posted up by the Vendor at the ICC 11/F Venue and/or (if applicable) the Additional Venues and/or on the Designated Website. Registrants will not be notified separately of the arrangement.
38.
