1. General provisions:

一般規定：

1.1. Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

1.2. Requirement of Selection

揀樓規定

(i) For each 3-bedroom (with enclosed kitchen) or 4-bedroom unit of any phase of the Development selected simultaneously, one studio unit included herein may be selected. No such studio unit may be selected unless as aforesaid.

每當同時揀選一個發展項目任何期數的三房(連梗廚)或四房單位，方可揀選一個包括在本銷售安排的開放式單位。除上文所述外，不可揀選任何該等開放式單位。

1.3. In case of any dispute, the Vendor reserves its right to allocate any specified residential properties to any interested person by any method (including balloting).

如有任何爭議，賣方保留最終決定權以任何方式(包括抽籤)自行分配任何指明住宅物業予任何有意欲購買的人士。

2. Subject to the provisions set out in “Other matters” below, first come first served. Persons interested in purchasing any specified residential property(ies) must attend the Sales Venue in person or by attorney pursuant to a validly executed power of attorney to select the residential property(ies) that the person wishes to purchase. The requirement of selection as set out in paragraph 1.2 above shall apply to the selection of specified residential properties. The Vendor does not accept any person interested in purchasing having queued up before the Time of the Sale on the date concerned.

- (a) The sale of the specified residential properties is subject to availability. Please note that the Vendor’s admittance of any person to the Sales Venue or the waiting queue thereof, does not guarantee that that person will be able to purchase any specified residential property. The Vendor may have sold a specified residential property under any previous sales arrangements in which case that specified residential property would become not available for selection hereunder.

Details will be announced on the website of the Phase of the Development (www.lemont.com.hk) and interested persons will not be separately notified of the same. The Vendor reserves the right to reject the entry of any person into the Sales Venue. The Vendor’s decision in this regard shall be final and binding on all persons.
