### **Batch A 第 A 批次**

#### **1. General provisions:** 一般規定：

1.1 The Vendor shall offer specified residential units in both Phase 1 of the Development (KT Marina 1) (“**Phase 1**”) and the Phase for sale at the same time on the First Date of Sale in the manner set out hereinbelow. Unless the context otherwise required, references to “**Unit(s)**” in these Information on Sales Arrangements shall be references to the specified residential properties in Phase 1 and/or the Phase. The Vendor also advises prospective purchasers to refer to the Information on Sales Arrangements No.62 of Phase 1 issued by the Vendor (as may be revised from time to time).

- (ii) a Relative of an Individual KT1 Purchaser; or
- (iii) a director of a corporate purchaser of residential unit(s) of KT Marina 1 (“**Corporate KT1 Purchaser**”); or
- (iv) a Relative of a director of a Corporate KT1 Purchaser; or

(b) in the case of a company:

- (i) a Corporate KT1 Purchaser; or
- (ii) a company of which the director is an Individual KT1 Purchaser, or a Relative of an Individual KT1 Purchaser; or
- (iii) a company of which the director is a director of a Corporate KT1 Purchaser, or a Relative of a director of a Corporate KT1 Purchaser.

1.4 The purchaser(s) shall enter into separate preliminary agreements for sale and purchase in respect of the Units in different phases respectively. Where more than one specified residential property is covered in one preliminary agreement for sale and purchase, the purchaser of each such specified residential property shall comprise the same person or the same group of persons.

## 2. Submission of Registration of Intent:

遞交購樓意向登記：

2.1 Balloting will be used to determine the order of priority for selection of the Units on the First Date of Sale. To participate in the balloting, interested persons must first submit a duly completed and signed Registration of Intent to Venue 2 during the following opening hours (i.e. 11:00 a.m. to 7:00 p.m. daily) on or before 25 April 2026 or Ground Floor, K. Wah Centre, 191 Java Road, North Point, Hong Kong on First Date of Sale during the following hours (i.e. 8:45 a.m. to 9:45 a.m.). Registration of Intent can be obtained from Venue 2.

2.2 Registrants interested in participating in Group A (including Group AA and Group AB) shall submit Group A Registration(s) of Intent. Registrants interested in participating in Group KT shall submit Group KT Registration(s) of Intent. Registrants interested in participating in Group B shall submit Group B Registration(s) of Intent.

2.3 Each Registration of Intent shall be submitted together with 1 cashiers' order in the sum of HK\$100,000 made payable to "Baker & McKenzie". The Vendor reserves the right to accept cheque(s) in place of the cashiers' order(s) for the purpose of submission of the Registration of Intent.

2.4 The order of priority for selection of the Units in Group AA, Group AB, Group KT and Group B will be determined by separate balloting. Group AA has a higher priority than Group AB; Group AB has a higher priority than Group KT and Group KT has a higher priority than Group B.

## 3. Applicable to Group A Registrants:

- 3.1 Group A Registrant interested in participating Group AA or Group AB shall (if the Registrant is a company, then any one of its directors or its authorized persons) attend Ground Floor, K. Wah Centre, 191 Java Road, North Point, Hong Kong on or before 9:45 a.m. on First Date of Sale and bring along his/her/their/its Identification Documents and the original receipt of the valid Group A Registration of Intent for pre-registration to participate in Group AA or Group AB (“**Pre-registration**”).

有意參與AA組或AB組的A組登記人須於出售首日上午9時45分或之前到達香港北角渣華道191號嘉華國際中心地下及攜同其身份證明文件及有效的A組購樓意向登記收據正本預先登記參與AA組或AB組（「**預先登記**」）。

- 3.2 Only Group A Registrants who have completed the Pre-registration for Group AA (“**Group AA Registrants**”) are eligible to participate in the procedures of Group AA. Only Group A Registrants who have completed the Pre-registration for Group AB are eligible to participate in the procedures of Group AB. For the avoidance of doubt, in respect of each Group A Registration of Intent submitted, a Group A Registrant may only participate in any one of Group AA or Group AB.

- 3.3 The process (including balloting) to determine the priority of Group A Registration of Intent for the selection of Units will take place on the First Date of Sale at Venue 1, and will be proceeded in 2 sub-groups (namely Group AA and Group AB) one after one. The Vendor will post and announce the attendance registration period(s) (“**Attendance Registration Period(s)**”) of different Group A Registrations of Intent in each sub-group on 25 April 2026 at or after 8:00 p.m. at Venue 1. Registrants will not be separately notified of the Attendance Registration Period(s). The Vendor reserves the right at any time, for the purposes of maintaining order and/or facilitating smooth sale of the Units, to adjust the time and date of the balloting and/or Attendance Registration Period(s). Any changes to the time and date of the balloting and/or Attendance Registration Period will be posted at Ground Floor, K. Wah Centre, 191 Java Road, North Point, Hong Kong. Registrants will not be notified separately of such changes.

決定A組購樓意向登記揀選單位之優先次序的程序（包括抽籤）將於出售首日於地點1進行，2個次組別（即AA組及AB組）將一個接著一個進行。賣方將於2026年4月25日下午8時或其後於地點1展示及公布各個次組別不同A組購樓意向登記之的報到時段（「**報到時段**」）。登記人將不獲另行通知報到時段。為了維持秩序及／或流暢地銷售單位，賣方保留權利在任何時間調整抽籤程序及／或報到時段的時間和日期。任何抽籤程序及／或報到時段的時間和日期的修改會於香港北角渣華道191號嘉華國際中心地下展示。登記人將不獲另行通知該等修改。

- 3.4 On the First Date of Sale, Group A Registrants shall attend Venue 1 according to the applicable Attendance Registration Period posted and announced by the Vendor pursuant to paragraph 3.3 above. Registrants shall bring along his/her/their/its Identification Documents and the original receipt of the valid Group A Registration of Intent for registration.

- 3.5 For Group AA, before the procedures of Group AA begins, the Vendor shall require the Group AA Registrants to indicate the number of Units intended to be purchased. Higher priorities of selection of Units will be given to a Group AA Registrant having indicated to purchase more Units.
