### **Part (I) : Registration**

#### **第(I)部分：登記**

1. All registrant(s) (if the registrant is a company, then any one of its directors) must attend the Sales Office to submit the following at or before 12:00 noon on 12 October 2024 (“the Deadline of Submission”):-

i. Registration of Intent duly completed and signed by the registrant(s) showing, inter alia, the number of specified residential properties which he/she/they intend(s) to purchase;

ii. each Registration of Intent must be submitted together with cashier’s order/cheque(s). The number of cashier’s order/cheque(s) shall be equal to the number of specified residential property(ies) which the Registrant intends to purchase as indicated in the relevant Registration of Intent. Each cashier’s order/cheque(s) shall be in the amount of HK\$100,000 and made payable to “Lo & Lo” ; and

2. Each registrant (whether in his/her/its own name or jointly with other(s)) can only submit a maximum of TWO (2) Registrations of Intent. Submission exceeding TWO (2) Registrations of Intent will NOT be accepted. A registrant shall not include both company(ies) and individual(s).

3. The cheque(s) (if accepted by the Vendor) previously submitted should be replaced by cashier's order(s) in the same amount which will be encashed to settle part of the preliminary deposit(s) of the residential property(ies) purchased (the balance to be paid by cheque(s)) if the registrant shall successfully purchase residential property(ies) in the Development on the date of sale. 4. If a Registration of Intent under any previous Sales Arrangement No.1 has been submitted thereunder and no specified residential property has been purchased in respect of that Registration of Intent, and the cashier's order(s)/cheque(s) accompanying that Registration of Intent has/have not been used nor collected by the registrant, that Registration of Intent will be deemed to have been submitted under the foregoing paragraph 1 (a "Deemed Submission"). The registrant holding that Registration of Intent is not required to complete registration again under the foregoing paragraph 1. The registrant or (where applicable) his/her/their authorized person shall bring along the original of Acknowledgement of Receipt of Registration of Intent and (where applicable) authorization letter to the Sales Office to obtain a new Acknowledgement of Receipt of Registration of Intent from the Vendor. For the avoidance of doubt, paragraph 2 above shall apply to a Deemed Submission, and a Deemed Submission is subject to restrictions under paragraph 2 above.

5. The order of submission of Registration of Intent will not have any impact on the order of priority for selecting the specified residential properties. Late submission will not be accepted. The Registration of Intent is personal to the registrant(s) and shall not be transferable.

6. Balloting will be used to determine the order of priority for selection of the specified residential properties on 12 October 2024. Balloting will take place at about or after 4:00 p.m. on 12 October 2024. The ballot results, including "registration number" and "ballot result sequence" will be announced at the Sales Office at or after 6:00 p.m. on 12 October 2024. Registrant(s) will not be separately notified of the ballot results.

7. Selection of specified residential properties will commence at or after 11:05 a.m. at the Sales Office on the First Date of Sale. 8. Each registrant must select at least one (1) but not more than three (3) specified residential properties. Where it is the turn of a registrant to select specified residential properties and that registrant fails to make a selection as aforesaid for whatever reasons (whether or not it is due to the insufficient number of remaining specified residential properties available for selection or otherwise), the Vendor shall have the right to revoke the

eligibility of such registrant for selection of any specified residential properties during the relevant time for such selection (the Vendor shall have the absolute discretion in this respect and its decision shall be final and binding on the registrants).

Card/ Passport of the registrant or (if applicable) a copy of Business Registration Certificate for the collection of the unused cashier's order(s)/cheque(s) at the Sales Office.

The Vendor does not accept any person interested in the purchase having queued up before the office hours of the Sales Office *or Sales Office 1 (as the case may be)*. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any interested person by any method (including balloting).
