(a) The Vendor does not undertake and is under no obligation to review, consider or accept the highest offer or any offer at all for the purchase of any specified residential property. The Vendor has the absolute right to withdraw from the sale of any specified residential property at any time before the acceptance of any offer. The Vendor has the absolute right to change the closing date and/ or time of the tender and/or the place where the sale will take place in respect of all or any of the specified residential properties from time to time by amending this Sales Arrangements and/or issuing new sales arrangements.

(b) Persons interested in submitting tenders of the specified residential properties are reminded to (i) enquire with the Vendor; and/or (ii) read the latest register of transactions of the Phase so as to ascertain whether a particular specified residential property is still available for tender on a date of sale. Although a specified residential property may be available for tender on a date of sale, it may become unavailable during that date of sale because the Vendor may accept a tender within 14 working days after the close of the previous tender exercise. ("Working day" is as defined in section 2 of the Residential Properties (First-hand Sales) Ordinance (Cap.621).)

(c) If Tropical Cyclone Warning Signal No.8 or above or Black Rainstorm Warning Signal is in effect in Hong Kong at or after 1:00 p.m. and before the closing time of tender on any date of tender, or where the Vendor considers that the safety or order is at risk at the place where the sale will take place and/or its vicinity on any date of tender, the tender of the specified residential properties on that day will be cancelled, and any tender(s) submitted on that day will not be accepted by the Vendor.
