1. The specified residential properties will be sold on a first come first served basis. In case of any dispute, the Vendor reserves its absolute right to allocate any specified residential properties to any person interested in purchasing by any method (including balloting).

2. Subject to paragraph 3 below, the party(ies) interested in purchasing any of the specified residential properties (“Interested Party”) must attend the Sales Office to select and purchase the specified residential property(ies) and

bring along (i) a cashier's order in the sum of HK\$100,000 made payable to "Kao, Lee & Yip Solicitors" or "高李葉律師行" for the purchase of each specified residential property in payment of part of the preliminary deposit; (ii) cheque(s) for payment of the balance of the said preliminary deposit; (iii) (if the Interested Party is an individual) Identity Card (Hong Kong/PRC/Macau) or passport (not applicable to holder(s) of Hong Kong, PRC or Macau Identity Card(s)), OR (if the Interested Party is a corporation) copy of its Certificate of Incorporation, copy of its Business Registration Certificate, copies of documents filed with the Companies Registry showing its current director(s) and secretary, copy(ies) of Identity Card (Hong Kong / PRC / Macau) or Passport (not applicable to holder(s) of Hong Kong, PRC or Macau Identity Card(s)) of each of the current director(s) of the Interested Party, and a certified true copy of resolutions of the board of directors of the Interested Party (in form and substance satisfactory to the Vendor) approving the Interested Party's purchase of the specified residential property(ies) and authorizing the director(s) to sign and submit all required documents for the purpose of such purchase; and (iv) (if the Interested Party is unable to attend the Sales Office to purchase the specified residential property) the original Power of Attorney (in the Vendor's prescribed form of Power of Attorney) duly executed by the Interested Party and the original identity document of such attorney.
